\_\_\_\_\_ I understand that tuition payments are not subject to reduction or refund due to absence from a holiday, vacation, illness, inclement weather, or **scheduled days** when child care is closed. Parents are not expected to pay tuition the week between Christmas and New Years.

\_\_\_\_\_ I understand that **all adults** listed on the front of this form are equally responsible for tuition payments

\_\_\_\_\_ If Joy Kids Learning Center decides **NOT** to open due to inclement weather, parents are **responsible** for payment for the first **two days**. Should Joy Kids close due to weather for **more than two days** parents are **not responsible for payment for those days**. This does not include scheduled days when Child Care is closed.

\_\_\_\_\_ Should Joy Kids Learning Center have to **close** due to a case of COVID-19, families are **responsible to pay tuition for the first week of closure**. Families are not responsible for payment for additional weeks of closure.
